METHOD OF PAYMENT

Acceptable methods of payment are:

- financial instruments such as **bank draft**, cashier's cheque, certified cheque or money order payable to "**Canadian Consulate General**"
- EPS direct debit (local bank cards only) for payments made **in person** only.

Please note:

- Applications submitted **without the correct fees or payment method will be returned to the applicant.**
- **Cash** and personal cheques will **NOT** be accepted.
- Payment must be in Canadian or Hong Kong dollars. No other currency will be accepted.
- If payment is made by financial instruments in Hong Kong dollars, **the payee bank must be located in Hong Kong.**
- Payment in Canadian dollars must be drawn on a bank located in Canada.

All processing fees must be paid when the application is submitted. The Right of Permanent Residence Fee (RPRF) may be paid at the time of application or at any time during processing before visa issuance.

No refund will be given if you pay the fee for a multiple entry visa, but the Visa Officer decides to issue you a single entry visa.
